- (iii) The domain name has been registered primarily for the purpose of disrupting the business of a competitor; or
- (iv) by using the domain name, registrant has intentionally attempted to attract, for commercial gain, Internet users to their web site or other on-line location, by creating a likelihood of confusion with the complainant's mark as to the source, sponsorship, affiliation, or endorsement of your web site or location or of a product or service of a web site or location.

In addition to remedies provided by the UDRP, section 4a(1)(2)(3) & b (1)(2)(3)(4) existing registrants, trademark and service mark owners are provided by US Domain Protection with a **first right to use preference** on domain names that are identical with new cc TLD, TLD extensions, or domain names that are confusingly similar to their own.

You are required to advise the domain notification processor of your intent to (a) secure this domain name or (b) release your first right to use preference.
