Vertical Integration – On 9-Nov, the VI Working Group published its Interim Report (Phase I). This Interim Report describes the absence of consensus within the VI Working Group for any recommendations for the first round of new gTLDs (Phase I of the PDP). With Phase I of the PDP complete, the VI Working Group will suspend its activities pending further instructions from GNSO Council for Phase II of the PDP, expected to focus on a long term solution for both new gTLD and existing gTLDs.

PEDNR (post-expiration domain name recovery). Initial report published 31-May. ICANN staff posted initial analysis of 412 public comments on 23-Aug, at <a href="http://forum.icann.org/lists/pednr-initial-report/msg00009.html">http://forum.icann.org/lists/pednr-initial-report/msg00009.html</a>. Final analysis of comments expected before Cartagena. Expect multiple PDPs to be spawned from the PEDNR project, with potential to affect both current and new gTLD contracts. Eventually expect multiple PDPs to be spawned from the RAP project, with potential to affect both current and new gTLD contracts. IRTP-B (Inter-Registrar Transfer Policy – Part B). initial report issued 29-May. Staff analysis of comments was posted 12-Aug at

<u>http://forum.icann.org/lists/irtp-b-initial-report/msg00017.html</u>. WG developing survey on the proposed Expedited Transfer Reverse Policy. WG members: Berry Cobb, Chris Chaplow, Mike O'Connor, Mike Rodenbaugh.

Joint working group on new gTLD Applicant Support. (requested by Board in Nairobi). Sent draft recommendations to Board before 24-Sep retreat. Board did not act on their report.

Internationalized Registration Data (IRD). Looking at IDN strings in Whois data. Presented report in Brussels. Plan a preliminary report by Cartagena.

Operations Steering Committee includes several sub-teams. Constituency & Stakeholder WT submitted recommendations on 15-Sep. Council Operations team submitted revised

procedures on 18-Oct. BC Members incl: Philip Shepard (chair), Ron Andruff, Zahid Jamil, Mike O'Connor, Mike Rodenbaugh

PDP-WT (Policy Development Process Work Team). Presented initial report in Brussels.
