Comment

The concept of 'public interest' mentioned in ICANN's Mission, Commitment and Core Values must be developed not only by ICANN and the community involved in its SO and ACs. Understanding that ICANN Mission is defined as: "ICANN's Mission is limited to coordinating the development and implementation of policies that are designed to ensure the stable and secure operation of the Domain Name System and are reasonably necessary to facilitate its openness, interoperability, resilience, and/or stability" It must be considered that ICANN policies related with the Domain Name System may have an impact national sovereing interests, going beyond this narrow mission.

Comment

As expressed in previous public comment periods and during several meetings and conference calls of the CCWG on Accountability, Argentina does not support the changes in the ICANN Bylaws proposed by Stress Test 18. Argentina does not find a reason for this Stress Test 18 to be a must for the approval of the IANA stewardship transition. Argentina believes that each SO and AC should have autonomy in deciding about its internal operating procedures, without any external constrain.

Argentina has participated in the accountability review process since the beginning and supports what has been agreed in the NETmundial Multistakeholder Statement: "it is expected that the process of globalization of ICANN speeds up leading to a truly international and global organization serving the public interest with clearly implementable and verifiable accountability and transparency mechanisms that satisfy requirements from both internal stakeholders and the global community". Argentina expects that the legal status/jurisdiction issue will be part the context of Work Stream 2, with the same level of attention and with a clearly established timeframe, that has been devoted to issues included in Work Stream 1. Argentina is willing to contribute working in Work Stream 2 in the same way as with Work Stream 1.
