Join a Working Group.

In ICANN's community Working Group model of decision-making, volunteer teams take on specific issues and arrive at recommendations and policies by consensus. What are working groups currently doing? Read the latest monthly Policy Update to find out. To learn about new groups seeking volunteers, watch for Announcements. Joining a working group allows you to focus your efforts on one specific issue for a limited time.

Volunteer for an ICANN leadership position.

Join a Constituency or User Group.

ICANN's diverse, international community includes several Constituencies that enable formally recognized interest groups to shape policies for the world's generic top-level domains (gTLDs). The ICANN community also includes a global network of individual Internet user groups that



provide input on a whole range of DNS issues of interest to individual users.

There are other membership opportunities for countrycode TLD operators, governments, and others. Each

group looks for different kinds of participation. Those soliciting members include:

Generic Names Supporting Organization (GNSO)

If you care about generic top-level domains (like.com, .net ...), you can join a Constituency of the GNSO, such as the Business Constituency, Intellectual Property Constituency, Internet Service Providers Constituency, or Non-Commercial Users Constituency.

At-Large Advisory Committee and Community (ALAC)

At-Large is the voice of the world's individual Internet user at ICANN. If you already participate in a group that wants to influence the Internet on behalf of individual users, consider registering it as an At-Large Structure (ALS).

Country Code Names Supporting Organization (ccNSO)

If you manage a country code Top Level Domain (.cn, .uk, ...), join the ccNSO. ccTLD managers in the ccNSO are addressing a range of issues critical to ccTLD operations.

Start a new Constituency.

ICANN encourages the formation of new Constituencies for participation in the GNSO. If you are involved with a specific and significant group of stakeholders that is interested in ICANN-related issues affected by gTLD policies - and you are considering sustained involvement in ICANN - you may want to explore creating a new Constituency.
