## The Pathfinder Initiative







A "Win-Win" for Civil Society and the Internet Civil Society and its NGOs, the Internet's largest stakeholder group, are increasingly dependent how the Internet operates and its rules and regulations in order to carry on their work. A Global Knowledge Partnership Foundation (GKPF) investigation into the state of NG presence on the Internet found low levels of domain name ownership, heavy reliance of social media sites, and low level of understanding around the growing challenges that will impact on their work, and their mission. The goal of the Pathfinder Initiative is to raise awareness and organizational capacity to engage in strategic Internet planning and to promote organizational voices in areas of Internet policy formation and implementation relevant to their work and their mission.

GKPF, working with a large NGO database, discovered that only 40% of its NGOs had operational websites with their own domain name, 30% had lost their registered domain name because they were unaware of domain name renew procedures or failed to maintain upto-date contact and billing information. 65% had moved their Internet presence to social media sites, with little thought of the risks to them, or to their collaborating partners, membership, and target constituency.

GKPF and its collaborators launched the Pathfinder Initiative to address these concerns, to help build effective Civil Society Internet use strategies, and to broaden and deepen engagement in crucial Internet ecosystem multistakeholder policy and implementation dialogues. Pathfinder Initiative activities are designed to produce win-win policy and practice outcomes.

#### Pathfinder Activities

### **Regional surveys**

Short surveys will be administered to raise awareness

and capture the Internet needs and concerns of NGOs and Civil Society. Survey results will shape regional Pathfinder efforts to broaden and deepen NGO/Civil Society engagement in relevant Internet ecosystem issues. GKPF has created a survey



platform < **survey.gkpf.org** > with a current survey request out to 1300 Civil Society organizations in Europe. Regionally adapted surveys are planned for Africa, Asia, and North and South America.

### Webinars and dialogues

Pathfinder webinar and dialogue events address vital operational concerns and effective strategic uses of

the Internet by Civil Society. Presentations from across Internet stakeholder groups address issues that are of direct concern to Civil Society's uses of the Internet. Two very successful webinars have been held: Washington, January 2015 - and Singapore February 2015.



# Face-to-Face meetings

Pathfinder conducts faceto-face engagements at regional events around the global. Given the uneven landscape of NGO/Civil Society engagement in the Internet, it is important, for example, to mount Pathfinder events in Africa around African NGO/Civil



Society concerns and issues. Pathfinder is partnering with others to promote multistakeholder awareness and engagement in the processes Internet governance, in the operational issues of the Internet ecosystem, and in dialogue around the rights and obligations of Internet citizenship.

# Capacity building events and resources

The Pathfinder webinars and face-to-face events will collaborate with a number of regional capacity building

processes. Pathfinder is initiating an online open access resource center focused on the creation and collection of resources regarding operational concerns and effective Internet use strategies



for NGOs and Civil Society. It will also build a body of materials dealing with the rights and obligations of responsible NGO/Civil Society citizenship in the Internet ecosystem.
